<b>6</b>	<p><b>Decision Report – Skate Park Location</b></p> <p>The Mayor summarised the meetings held with the public on the 8 February and the Special Council on the 13 February 2024, concerning the proposed location of the new skate park. Because of the feelings against this location by some it had been agreed by the Council that a further meeting was required to discuss this matter.</p> <p>The report from the Town Clerk was discussed and a lengthy debate followed where Councillors spoke both against and for the previously agreed new location.</p> <p>A motion was moved to carry out another consultation and to base a decision upon that result. This motion was not carried.</p> <p>A motion was then moved to locate the skate park on the previously agreed site. This motion was agreed.</p>
<b>6.1</b>	<p><b>Decision Report – Use of Current Skate Park</b></p> <p>This report had been deferred from a previous committee and depended upon the decision made in 6 above. Given that Members agreed that the proposed location be the site for the new skate park, this results in the original skate park being surplus to requirements. Potential uses were discussed as included within the report.</p> <p>Members considered these and agreed that Officers liaise with some of the groups that use this area e.g. Isabella heap volunteer’s group, Interact group, Rotakids group and a boot camp fitness group, to gather thoughts on any potential uses for this location.</p>
<b>7</b>	<p><b>Decision Report – Social Media Protocol</b></p> <p>Members discussed the suggested Protocol and agreed that it be implemented.</p>
