Minutes of the Meeting of the Environment Committee held at 6.00 pm on Tuesday 10 December 2024 in the Council Chamber, Arms Everytne House, Quay Road, NE24 2AS.

3	Minutes of the previous Environment Committee To note that the minutes of the previous meeting on the

	Environment Committee held on 19 September 2024 were agreed as a true record at the Full Council meeting on 10 October 2024.
4	Actions arising from the previous minutes None.
5	Environment Budget Monitoring Report The budget monitoring report was noted for information. The Town Clerk highlighted certain key areas of the budget, where there was an overspent e.g. Axwell Drive play area, due to additional expenditure at the location and extra fencing costs. However, he noted that the Council is expected to remain on target for the rest of the budgeted activities. An update was also given on the progress of the Skate Park, where the scheme costs are being supported by contributions from 2 Country Councillors using their MLIS funds.
6	Decision Report 1 – Bus Shelters The committee RESOLVED to accept the quotation 1 (£7,015.00) for installation of two new bus shelters and the moving of an existing shelter (£9,450) including traffic management. The costs for locating two shelters are being met by a County Councillor using their MLIS funds.
7	Decision Report 2 – Defibrillators (Brierley Road and Portland Wynd) The committee RESOLVED to agree to accept the Defibrillator and installation (£3,500) at Brierley Road. The cost is being met by a County Councillor using their MILS funding. However, the committee did not RESOLVE to agree to accept the installation of a defibrillator within the residential housing development at Portland Wynd, because of no permission being granted by the developer. The Town Council was asked to write to the developer outlining the Council disappointment in this matter.

<p>8</p>	<p>Decision Report 3 – Cultivator/Rotovator</p> <p>The General Services Officer presented his report to the committee to consider to not replace the Cultivator/Rotovator on the grounds of health and safety and management.</p> <p>After discussions, it was agreed not to purchase a new Cultivator/Rotovator, but to hire a contractor where deemed necessary, to carry out work at any necessary vacant allotments.</p>
<p>9</p>	<p>Decision Report 4 – Environment Committee budget for 2025/26</p> <p>The Town Clerk presented the report on the Environment Committee's proposed budget for the 2025/26 fiscal year. After a thorough discussion, the proposed budget was approved for further consideration and recommendations to the Governance Committee.</p> <p>Additionally, it was agreed that an assessment of 2-3 play areas would be conducted, and the findings would be incorporated into proposals regarding which play area(s) should be covered in the upcoming year.</p>
