# 7 Discussion and Decisions regarding Funding Applications

Members further discussed the individual applications and the following grant payments were agreed.

- 1. Blyth Royal British Legion was approved funding of £ 400 to support with the costs of marching band to lead parade to cenotaph for Remembrance services.
- 2. Blyth Resource & Initiative Centre (BRIC) was approved funding of £5,000 to contribute to the costs of employability tutor who manages drop-in services to support job search applicants and online assessments.
- 3. Blyth Tall Ship was approved funding of £ 10,000 to contribute to the cost of shipwright carpenter to run sessions and oversee the health and safety of volunteers.
- 4. Blyth Rugby Football Club was approved funding of  $\pounds$  5,000 to upgrade the third training pitch in the Southwest corner of the site with lighting to create an all-year training pitch. This funding would be conditional of evidence of planning permission approval being provided.
- 5. Briardale House Youth & Community Projects Ltd was approved funding of  $\pounds$  5,000 to employ a member of staff to facilitate older persons activities. Cllr Barras withdrew from the meeting during the consideration of this item.
- 6. Isabella Community Association was approved funding of £4,875 to offer local people free hot dinner once per week (Every Friday between 12.15 pm and 12:45 pm). Councillor Potts withdrew from the meeting during the consideration of this item. It was agreed that further information should be requested for this type of scheme in the future to ensure that a filtering system be included so that those more in need would benefit from the funding.
- 7. Cowpen Quay Community Association (Buffalo Centre) was approved funding of £ 5,000 to replace windows on the lower floor of the building to provide increased energy efficiency, reduce noise pollution, and improve security. Councillor Cartie withdrew from the meeting during the consideration of this item.
- 8. People and Drugs Ltd (Silx Teen Bar Youth Project) was approved funding of  $\pounds$  5,000 to contribute to the costs associated with evening provision in the Teen Bar.
- 9. ESCAPE Family Support was approved funding of £ 5,000 to support the costs of two sessional workers to support the Family Support Worker.
- 10. Northumberland Pride Limited t/a Pride Action North was

- approved funding of £ 1,250 to contribute to organising and delivering a family pride event in partnership with the South East Central Family Hub.
- 11. Citizens Advice Northumberland application was deferred subject to further information being provided on how much financial support has been provided from the Town/Parish Council sector in the last financial year.
- 12. Holding Hearts Therapeutic Services CIC was approved funding of  $\pounds$  3,450 to support them in continuing to provide the Grief Youth Group to bereaved children and young people in Blyth.
- 13. Community & Voluntary Action Blyth Valley was approved funding of  $\pounds$  10,000 to contribute towards core costs to enable the CVA to continue to provide services free of charge for the benefit of community groups delivering services in Blyth.
- 14. Newsham and New Delaval Youth Forum was approved funding of £10,000 to contribute towards salaries of the Senior Youth Worker and three part-time workers.
- 15. Blyth Spartans Juniors Football Club was approved funding of £5,000 to contribute to installation of specialist reinforced rebound fencing behind each goal at the Wensleydale pitch.

A total of £74,975 was approved for the above-mentioned organisations and groups.
